## **STATEMENT OF WORK**

### **1. DESCRIPTION:**

This is a statement of work to award a Firm Fixed Price contract for Conference Space, Meal, Dedicated parking, Lodging, and Hotel Services as described. Location requirement is in a 20 mile radius of Rochester, New York. Accommodations will be to host a Yellow Ribbon Post-Deployment Event for Military members and their guest. Date of event: October 02-03, 2010.

### **2. SCOPE OF WORK:**

#### **2.1. Meals.**

2.1.1. All meals must either be buffet style with multiple entrees or ala carte with a choice of entrees with sides, dessert, and non-alcoholic drinks. The Government will not pay for alcoholic beverages.

2.1.2. Gratuities, surcharges, and tips. All meals shall include all gratuities, surcharges and tips, etc.

2.1.3. Meals will be served and eaten in dining/ballroom. Vendor will clean up and remove all food items and dishes in an expedient manner upon completion of meals.

#### **2.2. Dining Room.**

2.2.1. Size and availability. Dining Room must be able to accommodate at least 120 guests. Room shall be available for lunch no later than 11:45 AM on Saturday, October 2, 2010. Room shall be available for breakfast no later than 7:30 AM on Sunday, October 3, 2010. Hotel personnel will be available for changes in room configuration when needed during normal working hours or as coordinated in advance.

2.2.2. Room layout. Room shall be set-up in round table format. Tables shall be covered with a tablecloth and arranged with banquet chairs. Tables will have pitchers of ice water and glasses on the tables.

#### **2.3. Meeting Rooms.**

2.3.1. Number of meeting rooms: 3 meeting rooms.

2.3.2. Size and availability. Meeting room #1 shall be set up in theater format and must be able to accommodate at least 120 guests. Meeting room #2 must be able to accommodate 20 vendors and display tables and enough room for 120 guests to visit each vendor. Meeting room #3 must be able to accommodate 30 children for daycare provisions. All rooms shall be available no later than 7:00 AM on Saturday, October 2, 2010 for final setup by presenters. Hotel

personnel will be available for changes in room configuration when needed during normal working hours or as coordinated in advance.

2.3.3. Layout. Meeting room #1 shall be set-up in a theater format with 120 chairs with podium, microphone, projector and screen for presentations. Meeting room #2: Guests will be visiting each vendor table throughout the day on Saturday. Area must accommodate 20 vendor tables. Meeting room #3 should be an open space to accommodate daycare areas for children. Cable television with DVD capability. Tables with seating for 20.

2.3.4. Dates and Times: Saturday, October 2, 2010, 7 AM to 5 PM. Sunday, October 3, 2010, 7 AM to 1 PM.

## 2.4. Lodging

2.4.1. Number of nights for lodging: One.

2.4.2. Type of lodging required: Overnight lodging must accommodate one military member and a maximum of two guests.

2.4.3. Date of Lodging: Saturday, October 02, 2010.

2.4.4. Number of lodging rooms needed for the event: 50

## 3. DEFINITIONS

3.1. CONTRACTING OFFICER: A person with the authority to enter into, administer and/or terminate contracts and make related determinations and findings.

3.2. CONTRACTING OFFICER REPRESENTATIVE (COR). Individual designated by the Contracting Officer to inspect work performed, to receive, approve and/or sign documents required to be submitted to the CONTRACTING OFFICER under this contract. The COR is not authorized to change any terms and conditions of this contract.

## 4. GOVERNMENT FURNISHED PROPERTY AND/OR SERVICES

4.1 The Government will provide a laptop for use in the conference/training room.

## 5. CONTRACTOR FURNISHED PROPERTY AND/OR SERVICES.

5.1 Registration Area on Saturday, October 2, 2010 from 8:00 to 9:30 am. Location to be determined upon consultation with COR.

5.2 Dining room tables with padded/cushioned chairs capable of seating the number of adult participants listed.

5.3 Podium with handheld wireless microphone.

- 5.4 Technical support. The vendor must have on-site technical personnel to provide technical assistance and repair training room equipment on the spot.
- 5.5 Conference area. Modern, clean and carpeted. Capable of accommodating the number of adult participants listed.
- 5.6 Banquet tables with table covering and skirting set up in dining room for Saturday luncheon and Sunday breakfast.

## 6. SPECIFIC TASKS

- 6.1. Meals. Two meals (one lunch, one breakfast) must be provided for adult attendees from lodging/hotel facilities. Two meals (one lunch, one breakfast) must be provided for child attendees from lodging/hotel facilities.
- 6.2. Type of meals to be provided: Hotel must be able to provide a buffet style set-up for all meals.
- (a) Noon meal, Saturday, October 2, 2010, 12 Noon. Number of meals: 120 adults, 30 children. Home style buffet: creamed chicken and house baked biscuits, beef burgundy and buttered egg noodles, fresh vegetable, whipped potatoes, garden salad, rolls and butter, cookies and coffee, tea, lemonade and iced tea.
- (b) Breakfast, Sunday, October 3, 2010, 8 AM, Number of meals: 120 adults, 30 children. Scrambled eggs, bacon, sausage, fresh cut fruit, breakfast potatoes, assorted boxed cold cereals, fresh baked pastries, juices, milk, coffee and teas.

  - (7) "U.S.-flag vessel" means a vessel of the United States or belonging to the United States, including any vessel registered or having national status under the laws of the United States.
- (b)(1) The Contractor shall use U.S.-flag vessels when transporting any supplies by sea under this contract.

(2) A subcontractor transporting supplies by sea under this contract shall use U.S.-flag vessels if--
