POSITION TITLE: Intelligence Officer	AREA OF CONSIDERATION: All candidates may apply who meet the basic qualification for this position and who are eligible for membership in the NYANG.
SPECIALTY SUMMARY (As outlined in AFMAN 36-2105) Performs and manages intelligence functions and activities to support United States and allied forces. Conducts information operations to include analysis of information vulnerability. Included are intelligence operations and applications activities; collecting, exploiting, producing, and disseminating foreign military threat information; geospatial information and services (GI & S) data application; developing intelligence policies and plans; and human, signals, imagery, and measurement and signature types of intelligence. Provides staff supervision and technical advice. Plans and coordinates use of intelligence resources, programming, and budgeting. Supports force employment planning, execution, and combat assessment. Advises commanders, government officials, and other users of intelligence information essential to military planning and aerospace operations. Related DoD Occupational Group: 230100.	
QUALIFICATIONS AND SELECTION FACTORS	
<ul style="list-style-type: none">- Selection for this position will be made without regard to race, religion, color, creed, gender or national origin.- Applications are subject to review by the FSS and as mandatory requirements are met, as outlined in applicable regulations, applicants must meet an Officer Screening and Interviewing Board (OSIB).- The requirements and qualifications prescribed in this announcement are minimum for nomination for appointment consideration. Appointment is not assured merely by meeting these requirements. Persons considered must further qualify with requirements outlined in ANGI 36-2005.	
KNOWLEDGE: Knowledge is mandatory of: means, methods, sources, and techniques used in intelligence operations, applications functions, and doctrine to include: collection, exploitation, production, and dissemination of foreign military threat information derived from human, signals, imagery, and measurement and signature intelligence; theories, principles, and application of the electromagnetic spectrum and United States and foreign space systems and operating parameters; applications of intelligence information to support military operations; target materials, analysis, and weaponeering; mission planning, force application and combat assessment; force protection; information warfare operations, associated countermeasures, threats, and vulnerabilities; and survival, evasion, resistance, escape, combat search and rescue, and Code of Conduct techniques and procedures. Additionally, knowledge is mandatory of: means, methods, sources, and techniques used in United States and allied military capabilities, organization, operations, and doctrine; intelligence systems and acquisition management; intelligence force management; national intelligence community structure and relationships; intelligence oversight; foreign military capability, limitations, and employment techniques; fusion, analysis, processing, and proper handling of intelligence information; analytical methods, forecasting, and estimating techniques; intelligence information handling systems; national and DoD regulatory guidance for conducting intelligence activities; and management sustaining functions such as intelligence communications and information systems, security, manpower, personnel, and training.	
EXPERIENCE: For award of AFSC 14N3, a minimum of 18 months' experience intelligence operations functions.	
EDUCATION: For entry into this specialty, undergraduate academic specialization or degree is desirable in physical, earth, computer, social, or information sciences; engineering, mathematics; foreign area studies.	

DUTIES AND RESPONSIBILITIES: Performs and manages intelligence operations and applications activities. Programs, plans, and evaluates operations and applications resources and activities. Establishes priorities. Conducts and manages collection functions. Oversees collection and exploitation activities of all sources of intelligence information. Manages production, processing, and dissemination of products. Develops, validates, and prioritizes targeting and (GI & S) activities and procedures. Plans and implements aircrew training. Determines unit requirements and tailors intelligence support to missions, equipment, and employment tactics. Establishes, recommends, and disseminates information and intelligence collection requirements. Conducts operations and related activities. Manages and integrates collected intelligence information. Integrates intelligence into information operations. Performs and directs intelligence briefings and debriefings of repatriates, defectors, émigrés, foreign nationals, and United States personnel. Manages collection requirements by validating, prioritizing, and coordinating user requests. Ensures operational needs are met through collection system tasking. Supports weapon system acquisition and force structure planning. Manages and coordinates intelligence activities. Reports aspects of operations and applications functions and responsibilities. Confers with government, business, professional, scientific, and other nations' organizations to provide support, exchange ideas, participate in studies, and coordinate on proposals and findings. Manages intelligence responsibilities of the Department of Defense Planning, Programming, and Budgeting System. Coordinates with personnel, materiel, planning, programming, and operational functions on allocation of resources, availability of funds, and preparation and implementation of operational plans.

OTHER QUALIFICATIONS:

- Applicant must be less than age 35 at the time of commissioning (waiver to age 40). Must satisfactorily complete the AF Officer Qualifying Test (AFOQT) prior to selection board and (after selection) pass a COMMISSIONING PHYSICAL. The AFOQT is forwarded for scoring to Texas and takes about two (2) weeks for the results to be returned. Applicant is encouraged to contact MSGT LINDA M. MIES @ (315) 233-2172 ASAP to be scheduled for the test. The results must be available prior to scheduling the OSIB. (Applicant may apply for position prior to test taking). When selectee is approved for appointment by the NGB, attendance of six weeks at the Academy of Military Science (AMS), McGhee-Tyson ANGB, TN is MANDATORY.
- Security Clearance: Must have TS/SCI clearance or be able to obtain TS/SCI. If not already awarded the TS/SCI clearance, applicants must complete and sign the SCI Pre-screening Interview (available on the 174FW Conversion CoP or in the Conversion Office). This must be attached to the application.
- Availability: Applicants must be available for shift work when required

APPLICATION PROCEDURES: Applicants will prepare and forward a cover letter, resume, letters of recommendation (optional) and other documents important to consider at potential interview **No Later Than Close of Business of Closing Date on Application.** If applicant is not yet awarded TS/SCI clearance, the SCI Pre-screening Interview must be attached to application. Board for the announcement will be held O/A 1-2 JUN 13.
